Curriculum Development

Foundations in Research (KSU HHS 888). Fall 2023. Major Revision.

In Fall 2023, I undertook a comprehensive overhaul of the HHS 888 curriculum, a graduate-level course focused on the fundamentals of research. This course is crafted to lay the groundwork for students in social science research methods, preparing them for a future in scholarly research. The revamped course, introduced in Fall 2023, features a project-based classroom environment. It includes weekly modular learning, pre-recorded video content, guest lectures, and a progressive approach to developing research proposals. This structure aims to equip students with a solid understanding of social science research principles.

Advanced Financial Planning (KSU PFP 305). Fall 2022. Major Revision.

I completely restructured the curriculum for PFP305 in Fall 2022, a junior level course that meets CFP® exam requirements. This course is designed to provide students with a foundation in financial planning and financial counseling and their many tenets, preparation for the CFP ® Exam and/or AFC® Exam, and for a career as a professional financial planner/counselor. I implemented the course in Fall 2022 in a flipped classroom model by filming reading videos, step-by-step financial modeling projects, Google Sheets analysis, and led workshops to stimulate students learning outcomes.
