RESEARCH PROGRAM

Couple and Family Functioning in Special Populations: The Effects of Crisis and Trauma on Individual, Couple, Family and Community Systems

Research Area #1:

Trauma Research, Education, & Consultation at K-State (TRECK) Team (1998 to present)

Project #1: Primary and Secondary Traumatic Stress in Couples (1998 to present)

This project has sought to obtain an empirical understanding of the systemic effects of traumatic events on adult interpersonal relationships. Trauma research traditionally has focused on how traumatic events impact the individual trauma victim. Literature on the long-term couple and family system effects in adults previously exposed to traumatic events has been limited. This program of research seeks to expand the empirical work on trauma in couples. In addition, this research project provides a unique educational and research opportunity by including both graduate and undergraduate students in the *Trauma Research, Education, and Consultation at K-State (TRECK) Team*, who are actively involved in learning and conducting the research methodology (under the direction of the PI). Since 1998, over 150 students have been involved with the TRECK Team, over 130 of whom have been undergraduate students.

The TRECK research program has consisted of three phases:

Phase 1: Beginning in June 2002, this phase focused on the secondary effects of trauma in couples where one or both partners have been exposed to a previous traumatic event (e.g., childhood abuse, war trauma, accidents). Qualitative and quantitative data were collected with 14 couples through the KSU Family Center and other community contacts. Qualitative data analysis was complete in January 2005, with manuscript preparation immediately following. Graduate and undergraduate student research assistants were involved in the research teams. All presentations and publications include undergraduate and graduate students as co-presenters/authors. Three publications have resulted from these data.

Phase 2: From August 2004 to September 2005, Phase 2 included 50 military couples from Fort Riley, Fort Leavenworth, and other areas of Kansas to understand how their recent deployment to *Operation Iraqi Freedom (OIF)* or *Operation Enduring Freedom (OEF)* (war trauma) impacts the soldiers, their partners, and their couple relationship. This second phase of research provided an additional participant pool facing an important current trauma-related issue in the U.S. As with Phase 1, graduate and undergraduate students have been involved in the research teams. Eleven

published manuscripts, four in review/in process manuscripts, and several student projects have resulted from these data.

Phase 3: Beginning in August 2015, we are conducting a 10 year follow-up study with the 50 Army couples from Phase 2. We are currently in the process of contacting these couples, and to date, we have collected data from 18 of the original participants. In addition, we have secured two internal grants for this follow-up study and are currently in the process of completing an NIH grant for additional data collection.

The research questions for these studies are:

- In what ways are the partners of trauma survivors (soldiers) affected by the primary survivor's previous deployment and trauma exposure (intrapersonal secondary traumatic stress symptoms)?
- In what ways are the couple's interpersonal functioning affected when there is a history of trauma exposure (interpersonal/systemic secondary traumatic stress symptoms)?
- In what ways do trauma survivors and their partners describe the impact of previous trauma exposure on their dyadic relationship? What mechanisms or moderating factors related to trauma exposure affect the couple system and functioning of the dyad?

A mixed-method research design was used in this research, which includes quantitative questionnaires that identify post-traumatic stress symptomatology in both partners and quality of the current dyadic relationship. The quantitative instruments included the Traumatic Events Questionnaire (Vrana & Lauterbach, 1994), Purdue Post-Traumatic Stress Disorder Scale-Revised (Lauterbach & Vrana, 1996), Trauma Symptom Checklist-40 (Briere, 1996), and Dyadic Adjustment Scale (Spanier, 1976). The qualitative interviews focused on the interpersonal impact of trauma on the couple relationship, intrapersonal effects of trauma exposure on both partners, and current dyadic functioning. All research projects have included a team-based approach, which includes undergraduate students, graduate students, and the TRECK faculty advisor. Students are included as co-authors and co-presenters on all TRECK projects if they commit to at least 2 semesters on the project and participate in the data analyses process.

Project #2: The Institute for the Health and Security of Military Families (2007-2017; Institute established in 2009) – www.militaryfamilies.ksu.edu

The Institute for the Health and Security of Military Families at Kansas State University provides research, outreach, training, and clinical service programs to address the complex effects of wartime service on the long-term health and well-being of military personnel, veterans, and their families. Topics of recent research include the effects of trauma and deployment on marriages, military children and deployment, financial behaviors of soldiers, health and well-being of military spouses, and violence prevention in military families. Launched in 2009, the Institute also provides clinical programs and retreats for service members, veterans, and their caregivers. The Institute is the "tip of the spear" for K-State's alliances with area military installations, the Kansas National Guard, Army Reserve, US Department of Veteran's Affairs, the Department of Defense, and other state and national organizations, providing support to the scientists and practitioners, students and faculty, from diverse disciplines across K-State who are addressing the health and well-being of current and former military service members and their families. The Institute engages graduate and undergraduate students through research, academic partnerships, and outreach programs with our military partners. The Institute Director was recognized in 2014 with a Department of the Army Outstanding Civilian Service Award for developing collaborations between key stakeholders working on behalf of veterans and military families. In 2016, the director received the Outstanding Civilian Service Medal from the Chief of Staff of the Army. The Institute is uniquely positioned to provide national leadership for engaged programs that target the needs of today's military personnel and their families.

Partnerships

Selected programs conducted at K-State and in partnership among the Institute and specific military and community partners are described below. The programs described here provide exemplars of the breadth of the Institute's engaged work.

Engaged Research Programs

Fort Riley KS Military Family Survey: Family Decisions to Accompany Soldiers Study (2008)

The purpose of this project was to better understand why families choose to accompany or not to accompany their Soldier when he/she is transferred to Fort Riley, Kansas. The study results provided Fort Riley commanders with information about the key factors and decisions that motivated families to accompany soldiers to Fort Riley, the factors that caused families to not accompany soldiers to Fort Riley, and recommendations for programs to improve family relocation to Fort Riley. Data from this study were utilized in developing the Fort Riley 2015 Strategic Plan.

Reintegration: Strong Marine Couples Program Evaluation (2015-2016)

The purpose of this project is to evaluate an educational workshop designed to help Marine couples with reintegration following deployment. This project involves a subcontract from the Military Family Research Institute at Purdue University. The Institute will conduct the evaluation of one program, the Marine Corps Mobilization and Deployment, Reintegration: Strong Marine Couples program, which targets couples 45 to 60 days following a Marine's return from deployment. The program includes workshops on understanding common changes that result from deployment, stressors and how to overcome them, communication, and other issues throughout the reintegration process.

Engaged Academic and Educational Programs

The Kansas National Guard Resiliency Project: Family Advocacy Program (2008-2009)

Operation FAST: Family Adaptation and Sustainability Training: Completed a resilience training manual that included information for spouses and soldiers for the Kansas National Guard, which consisted of current knowledge, practice, and application information relevant to current family issues (e.g., family financial resilience, coping with grief and loss, healthy relationships, conflict resolution, child and youth development). *Developed and provided the family resilience training component for the KNG Front Line Leaders resiliency course.*

Academic Partnerships and Internships (2012-2017)

Fort Riley KS Academic Internship Program: Developing academic partnerships with Fort Riley, specifically expanding the potential for academic internships for K-State students on post. We have worked with Fort Riley leadership and have estimated that there are currently around 25 K-State students in 7 academic areas completing academic internships at Fort Riley. The goal of this project is to expand opportunities for K-State students to 125 students in up to 35 different academic disciplines. This project has provided the opportunity for K-State to partner directly by providing academic expertise and students completing internships who can assist with the various programs for soldiers and families related to direct support efforts.

Other Academic Internship and Volunteer Programs: Since 2012, 12 undergraduate students have completed formal academic internships with the Institute, with another 15 students volunteering with various Institute programs. We also have referred 10 undergraduate students to two DoD/USDA Partnership national internship programs: Project Y.E.S! (North Carolina State University) and the Military Extension Internship Program (Purdue University). In addition, the Institute staff has included 1 AmeriCorps VISTA volunteer since 2013, who works collaboratively with the Institute, Operation: Military Kids, and Joining Community Forces throughout Kansas. We will be serving as the host organization for 3 VISTAs in 2015-2016, and will be submitting applications for 5 VISTA positions for 2016-2019.

Engaged Military Community Outreach Programs
Military Child Education Coalition (2012)

The Institute hosted the Military Child Education Coalition (MCEC) Public Engagement Event for Kansas, May 1-2, 2012, attended by 90 invited representatives from across Kansas. The Institute served as the primary facilitator for ongoing work implementing the action plan throughout Kansas. Key individuals in attendance included: Dr. Mary Keller, CEO/President, Military Child Education Coalition; Mrs. Patty Shinseki, Board member, Military Child Education Coalition (MCEC), Chair of MCEC's Living in the New Normal Initiatives and Board member of the White House Joining Forces Initiative; MG Lee Tafari, The Adjutant General of Kansas, and Mrs. Tammy Tafari, co-chair of the Public Engagement; BG Eric Peck, Deputy Adjutant General, Kansas National Guard; BG Donald MacWillie, Commanding General (Rear) Fort Riley, and Mrs. Sherri MacWillie.

National Military and Veteran Couples Retreats Program: National Veterans Wellness and Healing Center, Angel Fire NM (2011 to present); GratitudeAmerica, Marineland FL (2013-2015); Walter Reed Foundation, Bethesda MD (2015-2016)

The Institute has collaborated with these organizations in conducting military support retreats for Soldiers/Veterans and their spouses. The Program is specifically designed to assist Military Service Members, Veterans and their Families (SMVF) affected by deployment and/or combat by using a community-based, holistic, and multi-modal/integrative approach that provides a structure that includes ongoing **community-based programming** and peer support. The Retreats Program encompasses a psychoeducational and skills-training approach toward empowerment and destigmatization of post-deployment/post-combat stress effects. The program utilizes evidence-based traditional and holistic modalities when working with Veteran Couples/Families to include: psychoeducation, mind-body and complementary treatment interventions (e.g., yoga, massage, Tai Chi), and animal-assisted therapies. The Institute conducts the program outcome research for the Retreats program, as well as completing online applications and program evaluations. Preliminary data collection was completed in Summer 2015 with GratitudeAmerica; additional data are currently being collected with the National Veterans Wellness and Healing Center, Angel Fire NM, and the Walter Reed Society Foundation, Bethesda MD.

Project #3: Structural Equation Modeling Analyses with National Soldier and Veteran Datasets (2015-2018)

In the Fall 2015 semester, I audited FSHS 910 Advanced MFT Research Methods, with Dr. Jared Durtschi. My involvement with this class, which also included my two doctoral students in MFT, has piqued my excitement for statistics and using advanced analysis methods with large datasets. We are currently in the process of obtaining and conducting advanced statistical analyses with two large national data sets, described below. These projects provide cutting-edge quantitative and qualitative data to further bridge the fields of trauma and couple/family systems.

- Army STARRS (www.armystarrs.org)
 - Army STARRS is the largest study of mental health risk and resilience ever conducted among military personnel. Army STARRS data collection occurred from July 2009 - June 2015.
 - Public use datasets of Army STARRS survey data became available in June 2015 through the Inter-university Consortium for Political and Social Research (ICPSR) at the University of Michigan.
 - All Army Study (AAS)
 - The AAS includes representative Army-wide samples of Soldiers across all phases of Army service in quarterly samples.
 - The AAS survey data are available for 21,449 US Soldiers.
 - Our goal with the Army STARRS data will be to address systemic and interpersonal risk and protective factors for mental health and other health-related outcomes in Soldiers and their families.

Research Area #2:

National Down Syndrome Families Study: The Journey to Resilience and Hope in Parenting a Child with Down Syndrome (2009-present)

OBJECTIVE AND SPECIFIC AIMS

Although this research project arose from the PIs' personal experiences, the research program focuses on understanding the impact, particularly the positive effects, of parenting a child with Down syndrome (DS), as well as understanding the various aspects in this journey for families. The project includes a national dataset of 645 parents and/or caregivers (including fathers), that explores the journey to resilience and hope experienced by families with a member with DS. This research will identify the key resilience factors in families who have successfully navigated this difficult transition and provide empirically-based information and resources for families facing this journey in the future.

EXPECTED OUTCOMES AND SIGNIFICANCE

There are two primary outcomes from this project: 1) peer-reviewed journal or book chapter publications based on the research data, and 2) an edited book for helping professionals working with intellectual and developmental disability (IDD) populations and their families. This research will have a significant impact on the disability community, because the publications in this area often are not empirically-based. Many of the current mainstream publications for parents focus on either the plethora of problems facing children with DS in technical, medical language, or stories of experiences of parents that are not based on empirical information; they only include chapters of the parent's stories. The goal of developing an edited publications for professionals and parents of children with IDD, which will include the experiences of parents in their own words, as well as several key resources to help families on this journey, makes this long-term project of benefit to the IDD community, including parents, caregivers, professionals, and others working with children and adults with intellectual and developmental disabilities.

These projects will be further developed into academic publications/presentations, as well as other mainstream publications (e.g., newsletter articles, publications for parents and professionals, trainings for professionals). We are working directly with several national IDD organizations to identify avenues where this information will be most beneficial, as well as impacting legislative and public policy. In addition, we have just completed an edited book project for family members and professionals working with individuals with an IDD diagnosis that was released in January 2018.

Previous Research Projects:

Trauma and Reconciliation in Bosnia-Herzegovina (2000 to 2003)

This project, funded by the National Research Council (a division of the National Academy of Sciences), addressed the current needs of the people of Bosnia-Herzegovina. In 2000, an interdisciplinary team of researchers from the US worked in Bosnia-Herzegovina to determine potential resources for developing research programs and develop collaborations with international and US scholars. In 2001, I conducted research through a follow-up grant at Dom Bjelave Children's Home in Sarajevo. Information gained in this project have been developed into educational and research programs that focus on post-war recovery, particularly with the KSU Community Service Program International Summer Team in Bosnia, where I served as a consultant and collaborator with Marina Pecar, former College of Architecture faculty, for the team.

In 2003, this project involved the *Creative Education for Peace: Children and Families in Post-War Bosnia-Herzegovina Project*. The Co-PI was Marina Pecar, previously with the K-State Department of

Architecture, who is from Bosnia and has coordinated previous student projects in that region. We collaborated with Training Workshops International (TWI), a Virginia-based organization that has been working with children's homes in Bosnia since 1996. The teams consisted of graduate students, primarily in MFT, who provided educational and therapeutic activities with the children in the homes for two months during the summer semester. In 2003, two students participated in this project. In preparation, the CEP team met for 1.5 hours weekly for language and culture training, development of individual and group projects, and team coordination for their work in Bosnia. Funding was requested from the following federal sources and private foundations: ROTARY International (individual student funding was received), US Department of Education, and the Greenville Foundation.

Kansas All-Hazards Behavioral Health Program (KAHBH) (2005 to 2007)

The KAHBH program was developed through a contract between the Kansas Department of Health and Environment, Kansas Mental Health Authority (KMHA) of the Kansas Department of Social and Rehabilitation Services, and the Kansas State University School of Family Studies and Human Services. KMHA, KAHBH, and Community Mental Health Center coordinators form a linked network without hierarchy that works to ensure resources are adequate to meet the behavioral health needs of people in Kansas following disaster. The KAHBH program was responsible for the development of a State-wide behavioral health disaster response plan, recruitment of behavioral health volunteers, and maintenance of on-call disaster behavioral health volunteer list. KAHBH also was responsible for identifying and coordinating disaster related training for behavioral health disaster response workers. KAHBH developed a database of resources, including needs of special populations, interpreters, language banks, clergy, and family and peer support groups.

KAHBH was involved with community mental health centers (CMHCs) to design behavioral health disaster team structures and develop disaster response procedures. KAHBH consulted with CMHCs about planning and management of their responses to local disasters. KAHBH and local CMHCs worked closely with the local disaster agencies, behavioral health service providers, and other trained persons to provide crisis counseling services.

In May 2007, the first KAHBH response was initiated due to an EF5 Tornado that struck Kiowa County and the city of Greensburg in southern Kansas, followed by severe flooding in Southeast Kansas in late June. The response by KAHBH to these two Presidentially-declared disasters included behavioral health crisis counseling and outreach services to residents and responders in approximately 15 of the counties affected by the storms. The KAHBH Program, through SRS, received initial FEMA/SAMHSA Crisis Counseling Program grants to provide ongoing services in these regions through the KARE (Kansas Assisting Recovery Efforts) Projects. KSU served as the primary service provider, providing direct oversight and management of both KARE Projects, serving as the agency employing approximately 35 staff in these two regions, providing data reporting for the federal grants, and assisting with the coordination of services to residents in the affected areas. Responsibilities included:

- Activating KAHBH Teams and notifying CMHC Coordinators about need for KAHBH presence in Southwest and Southeast Kansas
- Providing outreach and crisis counseling services in Southwest and Southeast Kansas
- Organizing and coordinating KAHBH Team members and On-Site Supervisors responding to Southwest and Southeast Kansas
- Providing frequent updates on Southwest and Southeast Kansas response and continued need to CMHC Coordinators and KAHBH Stakeholders
- Preparing, revising, and submitting Immediate Services Program (ISP) and Regular Services Program (RSP) Grant materials with SRS coordinator to FEMA
- Providing education to responders and residents about crisis reactions and stress reduction
- Working with local and state responders to address behavioral health needs in the affected areas

- Conducting phone conference calls with local, state and federal offices
- Providing checks with KAHBH responders after they return home from their deployment
- Preparing Regular Services Program (RSP) Grant materials for extended funding of Crisis Counseling Program.
